

**Articulation Agreement for Transfer Credit and  
Transcripting of Credits Among  
Northeast Lakeview College, Northwest Vista College, Palo Alto  
College, San Antonio College, and St. Philip's College**

**Purpose**

To define how academic credit is transferred and accepted among Northeast Lakeview College, Northwest Vista College, Palo Alto College, San Antonio College, and St. Philip's College.

**Definitions**

Articulation Agreement: An agreement among institutions to accept transfer credits from one institution(s) by the other institution(s).

**Accreditation Status of the Colleges**

Northeast Lakeview College, Northwest Vista College, Palo Alto College, San Antonio College, and St. Philip's College are accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) to award certificates, associate degrees, and baccalaureate degrees.

**The terms of this agreement are below:**


- A. Transfer and acceptance of credit among Northeast Lakeview College, Northwest Vista College, Palo Alto College, San Antonio College, and St. Philip's College
  1. The colleges have processes and guidelines for sharing and collaborating on curriculum decisions. Each college has a curriculum development and review process aligned with the collaborative cross-college processes. Each college approves all curriculum decisions before they are discussed by the Alamo Colleges Curriculum Council (a cross-college faculty and vice-president of academic success group), and each is equally involved in the collaboration and decisions across the colleges.
  2. The colleges have a common core curriculum course listing, a consistent list of SLOs in courses offered at multiple colleges that can be augmented by each individual college, and consistent requirements for workforce certificates and degrees where offered at more than one college.
  3. The colleges ensure that qualifications of faculty comply with the faculty competency guidelines of the SACSCOC; each college selects its full-time faculty, and all have access to the adjunct faculty approved across the colleges. Each college uses the same faculty job description and faculty evaluation process and requirements. The colleges share faculty development opportunities offered at each college.
  4. The colleges agree, through this Transfer Articulation Agreement, that all credits earned at each of the colleges apply to the students' academic record. With the extensive review processes across the individual colleges, it is the responsibility of each college to ensure quality of academic offerings, credits earned at any of the colleges of the Alamo Colleges District are part of each college's credits. The colleges' catalogs and the student transcript reflect the sharing of courses.
- B. Credit Transcript Content
  1. The colleges agree to maintain a single student record for all students and share the student's academic record and credit is posted as transfer credit. The transcripts for each of the five colleges will follow the *Transcript Standard Agreement*.

**Term:**

The term of this agreement begins December 9, 2024, and will be reviewed on a biennial basis for continuous improvement.
