SPC students using Veteran & Hazlewood benefits should follow the guidelines below:

- If the veteran has qualifying service after 9/11/2001, Request COE from VA by applying here: <https://www.va.gov/education/how-to-apply/>
- Register for classes required for your degree
- Submit Request for Certification via the GUARDIAN Form System link provided
 - Complete all forms that are required per the table found below. Forms may be found on the SPC-VA webpage at the following link: [SPC Veterans Affairs](#)
 - Attach all required documents
- **Pay Your Balance BEFORE THE PAYMENT DEADLINE if your benefit does not cover 100%**
 - Use deferment form if you are unable to pay your outstanding balance
